She has an associate degree from St. Catharine Junior College, a bachelor's degree in elementary education from Eastern Kentucky University, a master's degree in education from Michigan State University, and a doctorate in education in curriculum and instruction from Virginia Tech.

Martha Ann's professional career includes work as a teacher for Montgomery County Public Schools (MCPS), supervisor of staff development for MCPS, and coordinator for inclusive practices for superintendent regions 7 and 8. She currently serves as the Dialogue on Race Montgomery County education chair, an NAACP Branch 7092 education committee member, a Blacksburg Baptist Church leadership committee member, a Delta Kappa Gamma member, and a New River Community College Educational Foundation board member. She has received several recognitions that include Virginia Tech Chapter Outstanding Educator Award for Phi Delta Kappa, Distinguished Alumni Hall of Fame for Eastern Kentucky University, the Branch NAACP Community Service Award for the local NAACP chapter, and NRV Leading Lights Distinguished Recipient. Martha Ann was also a featured teacher in the HBO short documentary "Educating Peter." Camden is also an active member of his church and donates his time to the children's ministry helping with both the nursery and children's church. He is also actively engaged in the missions work of the church, outreach ministry or gleaning turnips, or any other project. Camden is also a role model to his peers at Pulaski County High School and leads by example.

Jason's passion is bringing joy to children in his community through Hunters Helping Kids and Hunters Feeding the Hungry. Polly Myers, Montgomery County

Polly's faithful, consistent volunteer service includes work with Warm Hearth Foundation (Treasure Trove Thrift Store), RSVP of Montgomery County and Radford, and LewisGale Hospital Montgomery (LGHM). She has worked with Treasure Trove Thrift Store where she is a volunteer store clerk and helps with receiving and pricing donations, merchandising, cleaning, and greeting and assisting customers. The thrift store's sales support housing, health care, nutrition, personal care and pet food items for seniors living at Warm Hearth Village. At LGHM, she is a greeter and makes hospital visitors feel welcome. She has volunteered there for 11 years, giving over 2,000 hours of her time. She is also a previous recipient of the HCA Frist Humanitarian Volunteer Award.

Peggy Rasnick, Montgomery County

Peggy has been a volunteer with LewisGale Hospital Montgomery (LGHM) for more than 25 years, providing over 10,000 hours of volunteer service. During that time, she has served as a desk volunteer, a community helper volunteer, and an office volunteer, often greeting patients, visitors, and staff at the main desk. During the pandemic, Peggy was the lone volunteer, ensuring that things were done to ease the stress of the patients and the staff. She never wavered. Peggy has always been there to help those in need. She always has a smile and a hug for anyone who needs them. Beyond her selfless volunteerism, she has also encouraged friends to become volunteers for LGHM as well. Her love for the staff, patients, and fellow volunteers is endless.





Vern Simpson, Montgomery County

Vern has volunteered with the Blacksburg Interfaith Food Pantry (BIFP) for 15 years in numerous roles including the volunteer director and assistant director of the food pantry. His responsibilities covered the spectrum of operations including food acquisition and distribution, client screening, volunteer training, facility maintenance, compliance with Feeding America and NRCA guidelines, as well as many other tasks. After assuming the role of volunteer director, Vern began taking steps to encourage community involvement. He has organized the efforts of over 200 volunteers to ensure that food is obtained and distributed to over 7,000 low-income community members annually. Jean founded The Perfect Gift Shop, a free Christmas gift shop where low-income Floyd children and developmentally disabled adults can pick out gifts for their loved ones. Over five years, 1,100 children have benefited from the shop. She also formed Floyd Flower Power, a nonprofit partnership for Floyd that initiates and promotes planting native flowers around the Floyd community. Her volunteer work includes I-81 Dog Transport, a rescue dog transport, and Angels in the Attic, a nonprofit boutique. Jean also serves on the Floyd County Chamber of Commerce Board of Directors. In addition to her own volunteer work, Jean's positive, non-judgmental attitude draws diverse groups of volunteers across the county to support worthy causes.



Dora Butler, Radford

Dora is the former director of Radford Fairlawn Daily Bread (RFDB) and saw the organization through a major move to a new space in Radford thanks to a partnership with Long Way Brewing Company. Dora facilitated the partnership, which also brings in substantial donations through the brewery to the RFDB each month. Dora connected many to the mission of RFDB prior to the pandemic, but she was able to mobilize an entirely new volunteer set when most of her regular volunteers were elderly and therefore most vulnerable during the initial stages of the pandemic. She is a dynamic leader and a creative thinker, much needed qualities over the past two years. With her guidance, RFDB has also partnered with Radford City Public Schools and Unity Christian Church to ensure meals were available to children and seniors.

Susan Icove, Floyd County

Susan's service to her community spans many organizations including Jessie Peterman Floyd Library, New River Community Action (NRCA), Floyd Initiative for Safe Housing (FISH), Habitat for Humanity, Floyd County Community Development Block Grant home repair initiative, June Bug Center, and Smart Beginnings. Susan spearheaded fundraising to support the library expansion that included an internet cafe, computer lab, genealogy room, new community room, and front desk. Susan brought FISH to the table to help shape Floyd County's vision, leading to a \$1 million Community Development Block Grant to rehab 15 homes in the county. Her fundraising efforts were also instrumental to the completion of NRCA's Floyd area office building rehab, resulting in a beautiful Head Start three-year-old classroom, new preschool playground, community room, and more.



Lester Karlin, Montgomery County

Lester is a volunteer with the Blacksburg Volunteer Fire Department, the Blacksburg Volunteer Rescue Squad, and the Villas at Peppers Ferry Homeowners Association Board. On April 16th, 2007, he received the call and responded to the tragedy at Virginia Tech. He set up triage units, cared for victims, and transported the wounded. His actions were essential in setting up the scene before additional rescue personnel arrived. Lester was also an essential part of the community effort to obtain a Burn Building, a live fire training simulator. Lester's calming presence has provided emotional stability and reassurance to many individuals over the years. His leadership style and giving of himself has inspired others to do the same.
